#### Increase retirement savings.

Consider adding to your 401(k). If your employer doesn't offer a retirement plan or you have already met matching requirements, consider starting an IRA, which gives you more control over your investment options than with a traditional 401(k).

#### Invest in yourself.

Furthering your eduction or developing a new skill may get you closer to a promotion or a higher paying job. There are several low-cost, short-term options such as continuing education classes, online courses, workshops and seminars.

#### Make home improvements.

If you have repairs that need to be made but haven't had the funds, this is your opportunity. Or, consider making small improvements such as repainting or replacing fixtures and faucets, which can add value to your home.

#### Give back.

If you don't have debt and your savings for retirement is sufficient, think about making a charitable contribution to help others in need. Not only will you feel good about making a difference, but it may be eligible as a deduction in 2014 if you itemize.

For the 2014 tax year, individual investors can contribute up to \$5,500 to either a traditional or Roth IRA. If you're over 50, you can contribute an extra \$1,000. Contributing as much as you can as early as possible allows those assets more time to grow and compound.

You may also contribute up to \$17,500 to applicable 401(k), 403(b) and 457 plans, SAR-SEP plans, and the federal government's Thrift Savings Plan. For these plans, the catch-up contribution limit for individuals age 50 or older is an extra \$5,500.

## fraud alert common scams

Scam artists are becoming more creative in the techniques they use. Here are a few common pitches to watch out for.

"Just wire the money." According to the National Consumer League, wire transfers are a common way for con artists to steal cash from victims. There is no way to stop payment or recover the money.

"Cash this check." Scammers often win trust by sending their targets what looks like a real check. They may ask you to cash it and return all or a portion of the funds to them to cover fees or an overpayment.

"I'm contacting you from [insert foreign country]." Scam artists like to operate outside of the United States, where it is harder to be prosecuted.

"You are guaranteed a 10% return every month." Be cautious of any investment opportunity that guarantees a return.

"Don't tell anyone about this opportunity." A con artist will discourage you from sharing opportunities with anyone who would talk you out of it.

"Only a few lucky investors can get in, so you must act right away." Many scammers like to give the impression the deal has a deadline. Resist the pressure and research all information before making any major investing decisions.

When it comes to scams, use your best judgement. If something doesn't feel right or it sounds too good to be true, it probably is.
