- 4. Entries will not be returned.
- 5. Only official entry forms must be used.
- 6. Winners will be selected by independent judges, and winners will be notified by November 1, 2019.
- 7. A \$1,000 scholarship to the best entry in each of the following categories:
 - A. Ages 6 and under (as of January 1, 2019)
 - B. Ages 7 to 11 (as of January 1, 2019)
 - C. Ages 12 to 14 (as of January 1, 2019)
 - D. Ages 15 to 18 (as of January 1, 2019)

- In addition to the four (4) \$1,000 scholarships, Tinker Federal Credit Union will award a \$500 scholarship to the Honorable Mention winner in each category.
- 9. Award winners will be required to sign a Liability/Publicity Release (where legal) to receive their respective award. Awards may be reported as taxable income.
- 10. Checks will be awarded to the winning contestants by management of TFCU Financial Advisors and Tinker Federal Credit Union.
- 11. Employees and children of employees of TFCU Financial Advisors, Tinker Federal Credit Union and Raymond James Financial Services, Inc. are NOT eligible for the contest.
- 12. No correspondence will be given regarding the competition itself, and the selections of judges are final.
- 13. All entries must be received or postmarked by Monday, September 30, 2019.
