Booth Locations and Applicable Fees

Option 1: \$40 - Inside Booth Space  
Space is approximately 8' x 8'. TFCU will provide a table and two chairs. Inside space is limited. Applications will be accepted by the date they are received until spaces are filled. (Registration and Restrooms are also inside.)

Option 2: \$30 - Outside Booth Space  
Exhibitors may choose their own location as long as it does not interfere with the displays by car show participants. Exhibitors must supply their own fixtures/electricity. (Generators can not be disrupting or pose safety concerns.) If you choose to be in the parking area, your spot will be the same 1 1/2 parking space, as designated for a car show participant.

## AGREEMENT AND RELEASE

\_\_\_\_\_, Exhibitor, hereby agrees to the following terms and conditions of Tinker Federal Credit Union's ("TFCU") 18<sup>th</sup> Annual Miracle Car Show on May 5, 2018, at 4140 W. Interstate 40 in Oklahoma City, Oklahoma (the "Event"):

The Show Coordinator (a TFCU representative) will determine the location of the craft booths and any changes thereto. TFCU reserves the right to judge the acceptability of any items displayed and may require removal of any items judged unacceptable. TFCU also reserves the right to remove from the premises any Exhibitor displaying unacceptable items. No food or drinks may be sold from a craft booth, unless such food or drink is the craft being marketed by the Exhibitor or approved in advance.

In consideration of the acceptance of the right to participate, Exhibitor, by execution of this Agreement and Release, releases and discharges Tinker Federal Credit Union and its officials, directors, volunteers, employees, agents, representatives and servants, and anyone else connected with management or presentation of the Event (the "Released Parties"), of and from any and all known or unknown damages, injuries, losses, judgments, and/or claims from any cause whatsoever that may be suffered by any Exhibitor to their person or property, including any losses caused by the negligence or strict liability of the Released Parties. Further, each Exhibitor expressly agrees that Exhibitor will not sue or make a claim against the Released Parties for injuries and/or damages sustained as a result of participation in the Event and will indemnify and hold harmless the Released Parties from all claims, judgments, and costs, including attorney fees, incurred in connection with any action that may be brought as a result of participation in the Event. This release shall also prevent Exhibitors' spouses, heirs and assigns from pursuing any legal action or claim. Each Exhibitor agrees to observe all rules and decisions of the Event. Exhibitor understands that payment of any fees and execution of this Agreement are required prior to displaying any items.
